## IREF(UK): STATEMENT OF PURPOSE AND PRACTICE

**IREF(UK)** exists to promote and support the work of *The India Rural Evangelical Fellowship* in India. IREF(India) is engaged in evangelistic, church planting, compassion and educational ministries in the state of Andhra Pradesh. It is governed by a Board of Indian nationals. A video is available outlining the work of IREF. Further information is given in IREF(UK)'s publicity leaflets.

The **IREF(UK) Fund** exists to receive and pass on gifts for the work of IREF in India.

All donations to IREF(UK), (whether on-going sponsorship of pastor/evangelists and children, or one-off gifts for specified or general purposes), are passed on in full to IREF(India), unless specifically designated for the Fund's administration (postage, printing and promotional costs).

The IREF(UK) Fund is administered by a Chairman and Treasurer and other Trustees as appointed from time to time. The Treasurer is responsible for maintaining all financial records, issuing receipts, and an annual statement. Interim statements are prepared as necessary. Copies of the Annual Statement are lodged with IREF(USA) and IREF(India) and made available to all donors.

IREF(UK) is a Recognised Scottish Charity, no. SC033100. The IREF(UK) Fund is held in a Bank of Scotland's Treasurer's Account at the Brandon Street branch of *The Bank of Scotland, 9 Brandon Street, Hamilton, Lanarkshire, ML3 6BZ*. Cheques should be made payable to IREF(UK) [Account Number 00451308, Sorting Code: 80-08-25].

Donors are encouraged, whenever appropriate, to give by Gift Aid, thereby allowing IREF (UK) to recover tax from the Inland Revenue.

Donors are kept in regular touch with the work in India through periodic prayer letters. Further information is available on IREF's web sites.
